If the Purchaser selects to apply for the "Finance Scheme" mentioned in paragraphs (4)(iii)(b) above upon signing of the preliminary agreement for sale and purchase, the Purchaser, the Purchaser is not eligible for application of "Standby Second Mortgage" Loan mentioned in paragraph (4)(iii)(d) below but the Purchaser shall be entitled to a discount offered by the Vendor which is equivalent to 2% of the Price. The discount will be deducted from the Price directly. If the Purchaser after signing of preliminary agreement for sale and purchase finally selects not to apply for the "Finance Scheme" mentioned in paragraphs (4)(iii)(b) above, the Purchaser shall be entitled to a cash rebate provided by the Vendor which is equivalent to 4% of the Net Purchase Price provided that the Purchaser shall give a written notice to the Vendor to confirm that the Purchaser will not apply for the "Finance Scheme" not less than 90 days before the date of the full payment of the Purchase Price. The cash rebate will be offset from the balance of the Purchase Price of the residential property.
