Repayment of the principal amount can be deferred to a date on or before the Maturity Date.

The Purchaser may choose to instruct his own solicitors to act for him and in such event, the Purchaser shall also bear his own solicitors' legal costs and disbursements relating to the Super 1+2 Extended Second Mortgage Loan.

The Vendor or its associated company reserves the absolute right to decide whether or not to approve the Super 1+2 Extended Second Mortgage Loan.

The discount will be deducted from the Price directly.

The discount will be deducted from the Price directly. The cash rebate will be offset from the balance of the Purchase Price of the residential property. For the avoidance of doubt, even if the Purchaser after signing of preliminary agreement for sale and purchase finally selects not to apply for the "Finance Scheme" mentioned in paragraphs (4)(iii)(b) above, the Purchaser is still not eligible for application of "Standby Second Mortgage" Loan mentioned in paragraph (4)(iii)(d) below.

The Purchaser may choose to instruct his own solicitors to act for him and in such event, the Purchaser shall also bear his own solicitors' legal costs and disbursements relating to the Second Mortgage Loan.
