(If the Purchaser does not select to pay Purchase Price in full within 180 days from the date of the preliminary agreement for sale and purchase upon signing of the preliminary agreement for sale and purchase) Subject to contract, if the Purchaser pays the Purchase Price in full within 180 days from the date of the preliminary agreement for sale and purchase, the Purchaser will be entitled to a cash rebate equivalent to 1.5% of the Net Purchase Price provided that the Purchaser shall give a written notice to the Vendor to confirm that the Purchaser will pay the balance of the Purchase Price in full not less than 30 days before the date of full payment of Purchase Price.
