**On 11 February 2017 (the “first date of sale”):**

1. On the first date of sale, persons interested in purchasing the residential property(ies) shall carry out registration at 32/F, Tower 1, Enterprise Square Five, 38 Wang Chiu Road, Kowloon Bay between 10:00 a.m. and 10:30 a.m.. After registration is finished, selection of specified residential property(ies) will commence.

於出售首天，有意購買指明住宅物業的人士須於上午10時至上午10時30分於九龍灣宏照道38號企業廣場五期第一座三十二樓進行登記。登記完成後隨即進行揀選指明住宅物業。

2. Priority of selection of specified residential property(ies) in respect of an interested person\* will be determined by the number of residential properties intended to be purchased. A higher priority will be given to the interested person of whom the number of residential properties intended to be purchased is higher. If such numbers of residential properties of more than one interested person are the same, the priority among such persons will be determined by balloting.

揀選指明住宅物業的優先次序以每一個有意購買指明住宅物業的人士\*表明意欲購入之指明住宅物業數量決定，數量較多者優先。如多於一個有意購買指明住宅物業的人士表明意欲購入之指明住宅物業數量相同，該等人士之優先次序以抽籤決定。

\*An interested person consisted of immediate family member. Immediate family member, in relation to an individual, means a spouse, parent, child, sibling, grandparent or grandchild of the individual.

3. If there is no interested person in purchasing more than 1 specified residential property simultaneously. The above specified residential property(ies) will be sold on a first come first served basis.
